DORNEY PARK PROPOSED AS SITE OF 2012 REUNION

In an effort to increase the number of our active members and bring the richness of our family history and traditions to new generations, the board of directors of the Backenstoss Family Association has chosen Dorney Park as the site of our 2012 reunion. For those who may be unfamiliar with our local Pennsylvania attractions, Dorney Park is an expansive amusement and water park located near Allentown, PA. The date of our reunion will be Sunday, August 5, 2012.

Family members and guests who attend the Dorney Park reunion will have access to both the amusement and water parks from 10:00 A.M. to 10:00 P.M. From noon until 5:00 P.M., the Backenstoss Association will sponsor a pavilion, reserved for our members and guests, where we will hold our usual reunion activities. Included with the pavilion rental will be a five hour "All You Can Eat - American Classic" menu of hot dogs, hamburgers and soda.

All individuals age 3 and older attending the reunion will be charged the same group entrance fee, which this year is \$20.75. This rate is lower than any senior, child or discount ticket and far less than the current adult price ticket of \$39.99. There is a current parking fee of \$12.00 per vehicle. Please keep in mind that the pavilion rental AND the cost of the five hour "all you can eat" menu will be paid by the Backenstoss Association. While the costs associated with this reunion are greater than those of our recent gatherings, the proposed plan represents an incredible value when compared to duplicating the same Dorney Park experience without the family association sponsored group rate and meal plan.

We will need a minimum of one hundred attendees to qualify for the group rate and pavilion rental. While this number is greater than the attendance at our recent reunions, we hope the attractions at Dorney Park and the value provided by our group plan will attract new members, many of whom will bring their children. Your newsletter editor, Brian Bagenstose and his cousin Ken, our association treasurer, pledge a combined total of no less than 20 family members, so we are already 1/5 of the way to the number required!

We ask that family members who are interested in attending a reunion at Dorney Park read the additional information and follow the directions found on Page 6 of this newsletter.

If fewer than 100 people are able to commit to a reunion at Dorney Park, next year's reunion will still be held on the first Sunday of August at one of our usual locations. Specific information would be included in next year's newsletter.

From the Treasurer by Ken Bagenstose

I would like to thank everyone in the Backenstoss Family Association for making me feel welcome and appreciated in my first year as Treasurer of this great legacy organization. I am continually surprised at receiving contributions and other mailings from all corners of the continental United States and even from our original homestead country of Switzerland. We are a bigger group than 1 ever could have imagined!

For those of you who don't know me (and I assume that's most of you) I am cousin to Brian Bagenstose, first vice-president of our organization. My vocation is that of being chief financial officer for two Pennsylvania corporations; Crescent Brass Manufacturing in Reading PA, and Wilton Armetale, Inc., located in Mt. Joy PA about 20 minutes west of Lancaster. Crescent Brass is a non-ferrous foundry and machining manufacturer and Wilton Armetale is a producer of high-end cast aluminum giftware available at stores like Macy's, Bon-Ton, and Boscov's.

At last year's reunion I acquired a beautiful color photocopy of the Baggenstoss Family Shield provided by Ronnie Backenstoe (available for purchase at the annual reunions for \$3.00) and with it a brief description of its origin. [Excerpt from Ronnie's Shield publication]:

BAGGENSTOSS. Farmer since 1450. First appearance: Oath of truce of 1479 in the Canton Archives of Lucern. The family originated in Konstance. The Nidaldnerland family comes from the Gersau Baggenstoss family. It settled in Kirsiten in 1559 and became citizens there. Coat of Arms interpretation sources are the Ratserkanntnis book Bd. IV of 1780 up to 1794; from the Gatschet Coat-of-Arms book 1799, Bd.l, Bl. 200 found in the Canton Library of Bern. Armoral painting at the Council House of Gersau of the year 1907 and glass painting in the Priest's House of 1912. Arms: In red, painting upward is a shovei or spade with a wooden handle; on each side six-painted stars: red-silver; helmet adornment is an upright, red-clothed man with a spade in his right hand.

Using the information contained on that document I took a 'Google Earth' computer tour of the beautiful and scenic Gersau, Swtizerland area of our family's origin. For the unfamiliar, Google Earth is a free internet download and with it you can take a digital tour anywhere on our planet using satellite photographs and also view photographs that have been uploaded to their site from users all over the world.

So we have four elements coming together: A big family, a long proud history, a great rendition of the Baggenstoss Family Shield, and a modern manufacturing process capable of producing permanent reproductions of our family symbol that can be passed on to future generations. I asked the artists at Wilton to make a model of our family crest that would be suitable for reproduction in their patented cast aluminum style and the result is pictured on Page 7.

I personally think this is a beautiful item that can be proudly displayed. I plan to have a prototype of this 11" plate to see and touch at this year's family reunion. For those not able to make it to the reunion, please visit the Armetale website or one of the department stores mentioned above to get an idea of the fine quality of Armetale products. This plate will be equivalent to the items you can see there.

As always, the association will be grateful for any additional voluntary contribution purchasers of the plates may see fit to include with their yearly \$5 contribution.

This is a custom product and a one-time offer so we can only make them available on a presale basis. And to get the best price from the manufacturer we must buy at least 50 plates. I'm guessing that quantity won't be a problem based on the wonderful response we get each year during our contribution drive.
